SECTION 3 – HAZARDS IDENTIFICATION

Emergency overview: Harmful is swallowed. Causes eye irritation.

Extinguishing Media: Unknown

Unusual Fire and Explosion Hazards: Product will not burn but may spatter if temperature exceeds boiling point.

Special Firefighting Procedures: Containers can build up pressure if exposed to heat (fire). As in any fire, wear self-contained breathing apparatus pressure-demand (MSHA/NIOSH approved or equivalent) and full protective gear. Water runoff can cause environmental damage. SECTION 6 – ACCIDENTAL RELEASE MEASURES

Steps to be taken in Case Material is Released or Spilled

Ventilate area. Absorb spill with suitable absorbent material, then place in a chemical waste container. Avoid runoff into storm sewers and ditches which lead to waterways. If large spill, dike area and call spill response team. Notify appropriate state and local agencies.

SECTION 7 – HANDLING AND STORAGE

Handling: Wash thoroughly after handling.

Storage: Keep from freezing. Keep container closed when not in use.

SECTION 8 – EXPOSURE CONTROLS/PERSONAL PROTECTION

Engineering Controls: Good general ventilation should be sufficient to control airborne levels.

Respiratory Protection: Atmospheric levels should be maintained below the exposure limits listed in Section 2 by using engineering controls. If not feasible, use a NIOSH approved respirator.

Skin Protection: General use of chemical resistant gloves is recommended to protect the skin from drying and irritation. Lotions and barrier creams are also recommended to prevent drying of the skin.

Eye Protection: Eye protection is recommended.

Other Protective Equipment: If repeated or prolonged skin contact or contamination is likely, protective clothing should be worn.
